You may choose a long distance provided from those listed, however, you will receive a separate billing from the selected carrier for your Interlata and Intralata calls.

It is your responsibility to contact your chosen carrier and establish a Billing Account and/or Optional Calling Plan. Make sure and “verify” your plan/billing code to avoid future billing problems.
